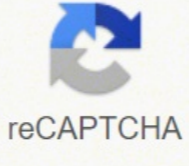

SB 442: Mandated Reporters

- Mandated reporters must report abuse immediately, which is now defined as no later than 24 hours from the time there is reasonable cause to believe the child has been abused.
- Hospitals, schools and other facilities which have internal protocols requiring child abuse reports to be made to the person in charge of the facility (who then reports to DFCS) are prohibited from exercising any control, restraint, modification, or making other change to the information provided by the employee reporting the abuse.

Can mandated reporters report abuse anonymously. Do mandated reporters report past abuse. Do mandated reporters have to report emotional abuse. Mandated reporters must report known or suspected instances of physical abuse within. How many hours does a mandated reporter have to report abuse. How much time does a mandated reporter have to report abuse.

If a minor is suspected of abuse, neglected or placed at an imminent risk of serious damage by a member of a staff of a private or public school or of an institution that takes care of it, the manager of the school or of the institute must inform the parent of the child or other person responsible for his custody of the complaint. As reported by represented reporters must report orally to the Department of Children and Families (DCF) Hotline or a law enforcement agency within 12 hours of suspecting that a child was abused or neglected and must present a written report (DCF -136 module) to the DCF within 48 hours of the presentation of the oral relationship. Relationships that meet the criteria are transmitted to a DCF investigator for rapid and appropriate intervention. What must be reported, the represented reporters are required to report or make a report when, in the normal performance of their work or profession, they have founded reasons to suspect or believe that a minor of 18 was abused, neglected or be placed a imminent risk of serious damage. Anyone who knows a false complaint of abuse or abandonment of minors will be fined up to \$ 2,000 or imprisoned for no more than a year, or both. CONGRATULATIONS! You have completed the CAIS / Vissta training program. The DCF is required to record all the relationships to the hotline. Where to call the department has a single point of contact at national level for the reporting of suspected abuses and abandonment of minors. However, depending on the circumstances, what can be necessary and / or advantageous. The DCF must inform the principal of the school that the complaint was made, unless this person is not the alleged guilty. What are the legal requirements of the «representati reporters» professionals who, since their work involves regular contacts with children, are obliged by law to signal suspicion abuses and abandonment of minors. Anonymity The represented reporters are required to provide their name when they make a report to the DCF, however, reporters may require anonymity to protect their privacy. Healthcare professionals may need to talk to parents to evaluate the cause of the child's lesion (I). This means that the DCF would not reveal their name or identity unless it is obliged to do so by law (Connecticut General Statutes, Sections 17a-28 and 17a-101). (Connecticut General Statutes A,§17a-101a) When making a report, a representative reporter is required to provide the following information, if notes: names and addresses of the child and his parents or manager (i) and child's sex nature and entity of lesion, mistreatment or negligence date and time approximate of lesion, mistreatment or denial occurred the circumstances in which the injuries, mistreatment or negligence came aware of the previous injury, mistreatment or negligence Minor or the brothers name of the person suspected of having caused the injury, the mistreatment or neglect of any action undertaken to treat or help the child any other information that the indicator deems useful have founded reasons to suspect or believe that less than 18 years it runs an imminent risk of abuse or has been victims of abuse or neglected, can and must present a complaint to the Hotline . This can I can OSSOP OSSOP E OIHCSIR IDNARG A POTENTIAL PENAL INDAGINS. Informing family warrant reporters is not required by law to inform parents who have made a report to DCF about their child. The Hotline worker collects critical information from the caller to determine whether a report meets Connecticut's legal criteria for child abuse or neglect. Anyone who suspects that a child has been abused or neglected or is at risk of abuse or neglect is strongly encouraged to call the Hotline. (See pages 4-5). Suspected abuse by a school employee Reporters in charge are required to report any suspected child abuse, negligence or imminent risk of serious harm directly to the DCF or the police. It is the responsibility of DCF to notify the head of such school, structure or institution that a report has been made. Unless a reporter gives his or her written consent, his or her name will not be disclosed unless: a DCF employs a police officer an attorney of the appropriate state assistant attorney general and all necessary parties in a legal proceeding a state licensing agency for child care, executive director of any institution, school, school, o school structure or superintendent If DCF suspects or knows that the reporter knowingly makes a false report, his or her identity must be reported to the relevant police agency and the person may be subject to the sanction described in the next section. The Child Abuse and Neglect hotline operates 24 hours a day, seven days a week. For a complete copy of the law, refer to Sections 17a-101 through 17a-103a, including the Connecticut General Statutes. Employers may not dismiss, discriminate against or take legal action against an employee for making a bona fide report or giving evidence in a court of law. abuse or negligence. procedure. procedure.
